



## PROVINCIAL TOWNSHIP AND RURAL ECONOMY GRANT FUND APPLICATION FORM

The Northern Cape Department of Economic Development and Tourism calls on all SMMEs and informal businesses in the Northern Cape Province to apply for the Township and Rural Economy Grant Fund. The grant financial support is offered for various economic activities and material, including market access, business equipment, and inventory stock.

The grant fund is targeted at Previously Disadvantaged Individuals (PDIs) operating micro, small and medium enterprises in townships and rural areas across 5 District Municipalities in the Northern Cape Province. The grant funding programme seeks to provide financial support to formal and informal enterprises in order to create jobs and impact the local economy. PDIs who own businesses in Towns or City settings will also be considered.

This grant fund is targeting all enterprises that have been operational for more than a year. No Start-Ups will be considered. Only enterprises owned by **people living with disabilities may be considered as Start Ups**

### Categories of businesses to be considered and conditions of the grant include:

- Sole Traders/ Proprietors
- Informal Traders
- Close Corporations
- PTY LTDs
- Co-operatives
- The grant will not exceed R100 000 worth of material and equipment.

### Grant Fund Criteria

Any business wishing to apply for support from the **Township and Rural Economy Grant Fund** **must** complete the compulsory **grant application form** and meet the prerequisite criteria requirements.

Qualifying applications must submit compliance and supporting documents to be considered for assessment and these are:

- Completed grant application form;
- Founding Documents & Registration Certificate **(N/A to Informal Traders)**
- Certified ID Copy(s) of Director(s) **(Including Informal Traders)**
- Valid Tax Clearance Certificate; **(N/A to informal Traders)**
- Bank Confirmation Letter **(Not compulsory for Informal Traders)**
- 6 or 12 months Financial Records or 12 months Bank Statement or 1 year Financial Statement or Management Accounts Report or any other method to prove business activity; where possible.
- Affidavit on ownership declaration **(Informal Traders)**.
- Enterprise must be operational for more than one year to be eligible for the grant.
- Consent to conduct enterprise status verification.
- Quotations of material and equipment required (Not older than 3 months from the date the advert was circulated)

- Signing of the declaration of acceptance also allow DEDaT and its stakeholders to source quotations for SMMEs where they deem fit,
- If application is successful, the applicant/s will be expected to attend an induction session and also expected to sign a Service Level Agreement (SLA) ensuring that the material and equipment purchased will be used only for the purposes declared in the application
